REVISED NOTIFICATION

Sub: Migration Transfer of students pursuing Health Science

courses in affiliated colleges of RGUHS.

Ref: Minutes of meeting of Syndicate held on 11/03/2008.

1. AUTH/Migration Transfer – Students – 354/2008-09, Dated: 15/03/2008

2. Notification No:- Auth/Mig-Transfer-students/Misc-04/2016-17, Dated:22/08/2016.

In exercise of the powers conferred under Section 35 (1 & 2) of RGUHS Act 1994, the Syndicate in its meeting held on 11/03/2008, is pleased to notify the following conditions for Migration Transfer from one college to another college affiliated to RGUHS.

RGUHS has prescribed general guidelines/conditions for migration transfer of students from one college to another college affiliated to RGUHS in the Notification cited under reference. While framing these guidelines, university has adopted the guidelines issued by National Medical Council of India, New Delhi for medical students. It is noted that the guidelines issued by apex bodies of other faculties are not in conformity with the guidelines thus adopted. There are some faculties that have no apex bodies. Hence, this notification.

Sl. No	Particulars
1.	Apply the guidelines of the respective apex bodies as available at the time of processing of applications of migration transfer wherever they are available.
2.	Follow the guidelines issued in the concerned ordinance wherever apex bodies rules are not available.
3.	 a) To issue No Objection Certificate of both the colleges that are affiliated and agree for Migration Transfer b) Availability of vacant seats in the receiving college should mention clear vacancy. c) If applied within one month of announcement of results wherever no regulations are prescribed either by the apex body or by the University.
4.	Migration Transfer is not allowed for students of Post Basic BSc Nursing and to all post Graduate courses.
5.	Applicable Migration Transfer Fees to be paid as per RGUHS norms.
6.	Migration Transfer shall be effected only in exceptional cases on extreme compassionate grounds. (Death of a supporting guardian, illness of the candidate causing disability and disturbed conditions as declared by Government in the college area).
7.	Both the colleges i.e one at which the student is studying at present and one to which migration is sought shall be recognized by the respective apex body.

	in all subjects
8.	The candidate should have passed I year Professional examination in all subjects in the first attempt only. In case of nursing, "Migration is allowed at any level but only after completion of one year of training and on the condition that the student passes in all the subjects of 1st year and subsequent years, as applicable"
9.	The candidate shall submit his application for Migration transfer in an respect of all the authorities concerned within a period of one month of announcement of announcement of the state of declaration of result) the Lyear / Ist Professional examination.
10.	The candidate must submit an affidavit stating that he/she will pursue presented study before appearing at II year /IInd professional examination at the transferee college, which should be duly certified by the Registrar of the concerned University/Principal of the college in which he/she is seeking transfer. The transfer will be applicable only after receipt of the affidavit. Migration Transfer will be allowed only once in their academic tenure.
11.	Migration during clinical course of study (wherever applicable) shall not be allowed on any ground
12.	All applications for migration shall be referred to RGUHS and Apex Body concerned by college authorities. No institution shall allow migrations directly without the approval of RGUHS and Apex Body concerned.
13.	RGUHS reserves the right, not to entertain any application which is not under the prescribed compassionate grounds and also to take independent decisions where applicant has been allowed to migrate without referring the same to RGUHS.
14.	However, in view of closure of any affiliated college under RGUHS migration transfer may be allowed.
15.	The above ordinance shall come into force for the students taking admission from the academic year 2022-23 onwards.
16.	No Migration will be permitted on any ground from one college to another located within the same city.
17.	Candidate seeking Migration Transfer from one institution to the other institution located in different state/University such of these cases may be subject to approval by the concerned apex body/competent authorities.
